NEW CBC/CFC-2022, NFPA 72-2022, 1221-2019 and 1225-2022 CODES UPDATS FOR: Two-Way Emergency Communications Systems (ECS) and **Emergency Responder Communication Coverage Systems (ERCCS)**

The 2022 Edition of CBC and CFC will become effective in CA on 1/1/2023. These Codes includes many significant changes regarding ECS and ERCCS which will be discussed and clarified in this class. The referenced standards for these systems which will become effective in CA on 1/1/2023 are NFPA 72-2022 (ECS) and NFPA 1221-2019 (ERCCS). However NFPA 1225-2022 may become effective during the 2022 intervening Code Cycle for ERCCS. All the specific design, installation and enforcement requirements in these standards will be discussed and clarified in this class. **CLASS OVERVIEW**

- This class will focus on the NEW requirements for In-buildings Two-Way Emergency Communications Systems (ECS) and ERCCS which are specified by IBC/CBC/IFC/CFC to be provided in specific occupancies and buildings. This class will discuss ALL types of ECS and will clarify where these systems are required to be installed.
- > NFPA 72-2022 includes NEW UL listing requirements (UL 2525) for Area of Refuge (AOR), Stairway, Elevator Landing, and Occupant Evacuation Elevator Lobbies ECS. NFPA 72-2022 includes NEW pathway survivability requirements for ECS with a NEW Pathway survivability (Level 4) . CFC-2022 includes NEW listing requirement (UL2524) for all new ERCCS equipment effective 1/1/2023 which will be discussed and clarified,
- > CFC-2022, NFPA 1221 and NFPA 1225 includes new requirements for ERCCS monitoring and critical areas coverage. CBC-2022 includes new requirements for 2-Way ECS in locked elevator lobbies in High-Rise buildings to be controlled from an Off-Site location - This specific CA requirement will be discussed and clarified.
- Leaky-Coax cables provisions in Elevator Hoistways to serve ERCCS are included in the 2022 national Elevator Code (A17.1) and they will be discussed and clarified.

Monitoring-For-Integrity Requirements and supervision of ECS and ERCCS by the Building FA System or by a dedicated function(s) fire alarm control unit where a building FA system is not installed will be clarified.

NEW Pathway Survivability requirements per NFPA 72 Ch. 12 (Level 4) based on Type of construction and Fire Rating, including new available and listed 2-HR Coaxial Cables per UL 2196 and associated CI & CIC listing. NEW CBC-2022 Chapter 30 Requirements for Elevator Live-Video Communication System based on A17.1-2019 and Elevator Car Phone - 60 feet rule will be discussed and clarified per DOSH requirments.

The Class will include an UNLIMITED Questions & Answers Session at the end of each day starting at 1:00PM to discuss the class material and any other associated questions.

The ICC certificate will be provided to each participant who has completed both sessions.
